



**Introduction**

- Does vasectomy (a safe means of permanent contraception offered to couples in a stable relationship) trigger marital breakdown?
- **There are no publications or guidelines**

**Objectives**

Explore an association between vasectomy & relationship breakdown. This is the first study ever.

**Patients and Methods**

- Local ethical approval was granted in 2012
- 1832 vasectomy procedures between 1996 and 2008 in Aberdeen Royal Infirmary
- All were sent a validated sensitive questionnaire
- Validation method: test re-test
- 13 men attending for vasectomy reversal (chosen at random) were interviewed at length

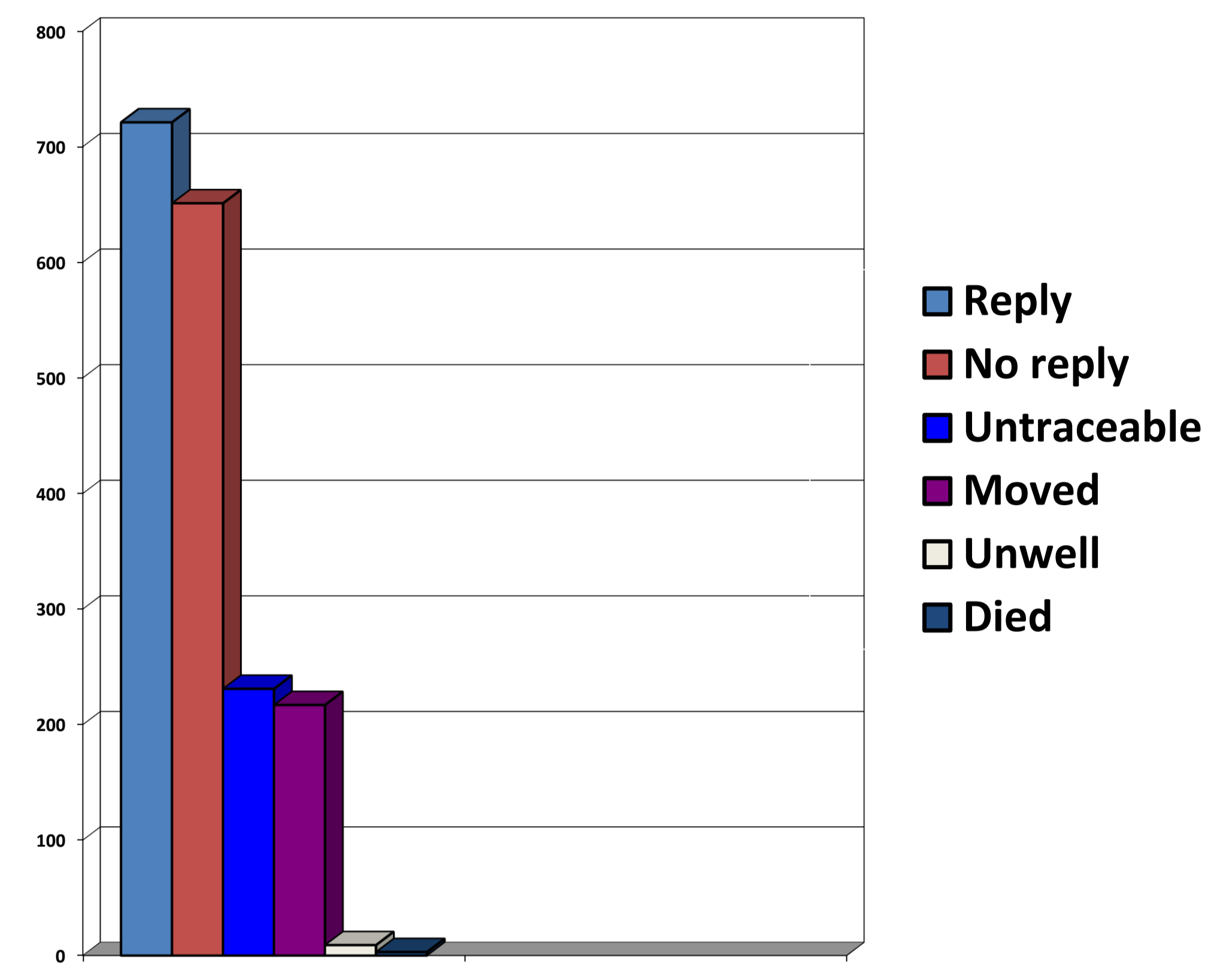

**Results**

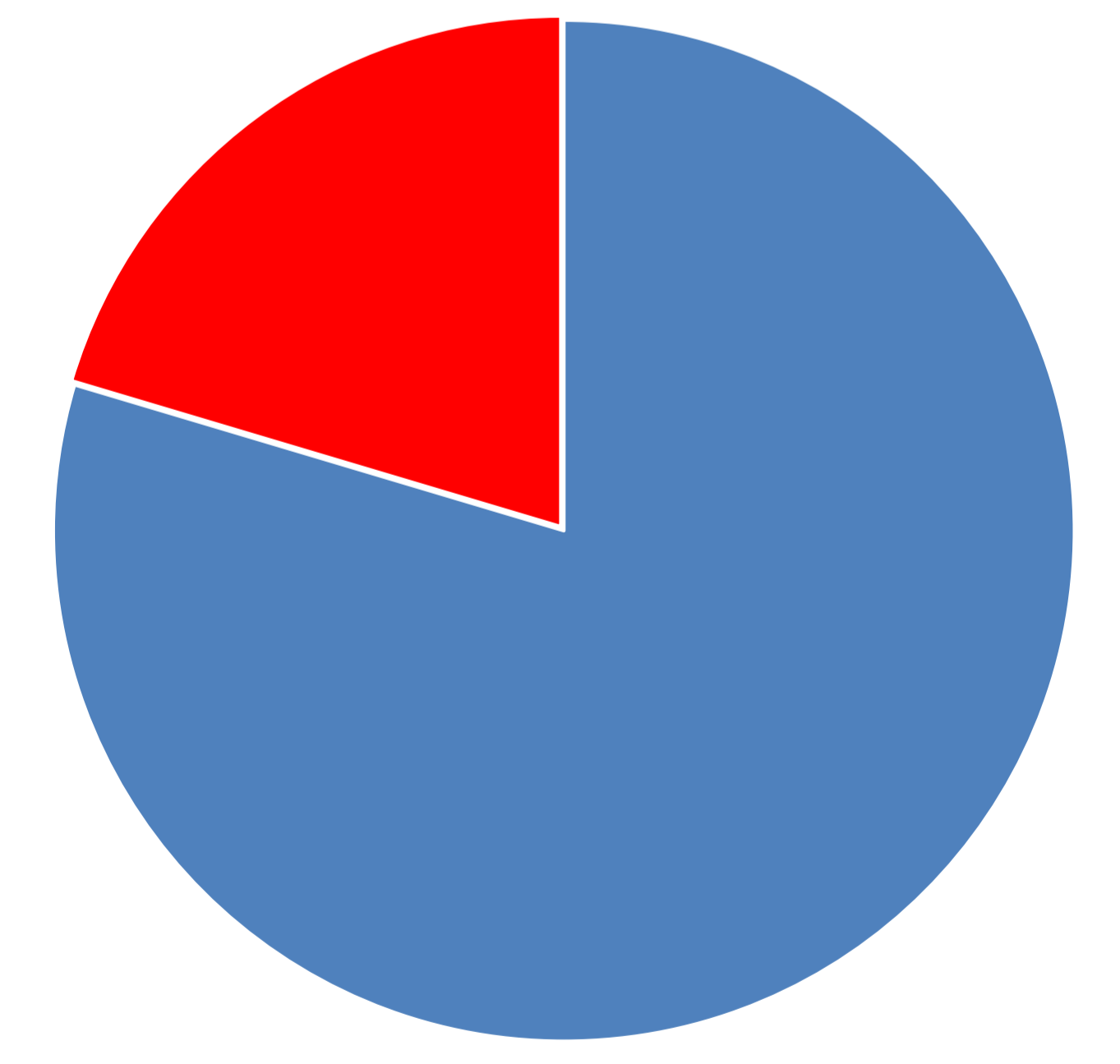
**Replies**

721 responded, 651 no reply, 231 untraceable, 217 had moved, 9 too severely ill to reply & 3 had died from unrelated causes



**Satisfaction, pain, regrets & sexual dysfunction (all patients)**

Number (%)	Outcome
660 (91.5%)	Satisfied with procedure
232 (32%)	Short/Long-term pain
43 (6%) men & 32 (4.4%) partners	Had regrets
75 (10%)	Sexual dysfunction



- 147 (20.4%) were separated, divorced or re-married
- 49 of these (33%) blamed the vasectomy for the relationship breakdown
- 7 of 13 (54%) attending for vasectomy reversal blamed the vasectomy for the relationship breakdown

**Results**

**Relationship breakdown**

- Data from the hospital patient administration system: A significant % of the 231 untraceable & the 217 who moved were either separated or divorced
- 7 (54%) of 13 vas reversal interviewed blamed the vasectomy for the relationship breakdown
- 22 had vasectomy reversal & 35 requested but were denied reversal (not NHS procedure from April 2009)

**Satisfaction, pain, regrets & sexual dysfunction (relationship breakdown)**

Number (%)	Outcome
121 (82%)	Satisfied with procedure
48 (32.7%)	Short/Long-term pain
37(25.2%)men & 32(21.8%) partners	Had regrets
43 (29.3%)	Sexual dysfunction

**Comments (from patient questionnaires)**

“No Complaints! – Now have prostate cancer – assume no connection – under treatment”

“Wife wanted 3<sup>rd</sup> child 3 years after vasectomy – I said no!” [separated]

“I did not want a vasectomy, my Ex demanded it if I wanted sex! She did not want children” [Divorced after 1 year]

“Had the procedure twice – pain since, have gone downhill since including my relationship” [Separated]

“Vasectomy was the worst thing I had by the NHS and I cannot get reversal” [separated]

“Separated from girlfriend for 2 years then got back. I think having the snip seemed that I did not want kids from her. Now sorted ”

**Conclusions**

- Vasectomy is associated with relationship breakdown (first study ever)
- Sexual dysfunction, pain, regrets, unknown psychological factors may play a role
- Couples should be adequately informed & counselled
